

Information pursuant to art. 13 of EU Regulation 2016/679

Time- Lapse

1. Premise

For Kedrion SpA (hereinafter, for brevity, also simply "**Kedrion**") your privacy and the security of your personal data are particularly important, which is why we collect and process them with the utmost care and attention, while at the same time adopting specific technical and structural measures to guarantee the full security of the processing.

We therefore inform you, pursuant to art. 13 of European Regulation 2016/679 (hereinafter " **Regulation** ") that the processing of your personal data is carried out in ways that are suitable to guarantee their security and confidentiality, as described in this information.

2. Data controller and contact details

The processing of your personal data is carried out by Kedrion SpA (hereinafter also simply "Kedrion"), as Data Controller, pursuant to and for the purposes of the Regulation.

3. Data Protection Officer

The Data Controller has appointed a Data Protection Officer or Data Protection Officer Officer (" **DPO** ") who can be contacted, pursuant to art. 38 par. 4 of the Regulation, for all matters relating to the processing of personal data and the exercise of the rights deriving from the Regulation.

4. Type of data processed, purposes and legal bases of the processing

The personal data that Kedrion SpA processes, according to the methods set out in paragraph 6 of this information notice, are:

 Images depicting his person, as collected by the video recording system which will be described below.

The personal data collected are processed for the following purposes and related legal bases of reference:

"Time- Lapse " in relation to the activities carried out for the construction of the new production complex located in Bolognana (LU); subsequently this video will be used and distributed for promotional purposes by Kedrion. "Time- Lapse " is a video recording technique used to document small changes that occur in sequence. In essence, photographs are taken at regular shutter speeds and then edited into a video in post-production.

5. Nature of data provision

The provision of personal data is implicit in its passage within the cone of the cameras that make up the video recording system.

6. Data processing methods

The video recording system is composed of three cameras that, every thirty minutes, will acquire an image from the same angle.

This activity will last twelve months starting from 06.20.2025 and will be carried out by a Supplier specifically appointed for this purpose by Kedrion.

At the end of this period, the images will be anonymized by the Provider using specific pixels in order to prevent the people filmed by the cameras from being recognizable.

Once the images have been anonymized, the Supplier will transmit the video in "Time- Lapse " format to Kedrion.

Once the video has been delivered, the Supplier will delete the recorded images and the video will be used by Kedrion, in an anonymous form, for promotional purposes as indicated above.

It is therefore specified that Kedrion will not have access, for any reason, to the images prior to their anonymization and re-edition and in no case and in no way may they be used for the purposes of remote monitoring of work activity.

7. Communication of data to third parties

The images will be collected and processed by a Supplier with whom Kedrion has signed a specific deed of appointment as Data Controller pursuant to art. 28 of the Regulation in order to carry out secure processing of personal data.

Once the post-production editing of the "Time- Lapse " video has been completed, it will be distributed for promotional purposes as described above.

8. Place of processing – Transfer of data outside the EU

The Data Controller will not transfer your personal data to countries outside the EEA.

In the event that some of the third parties are based or use Clouds located in countries outside the European Union, we inform you that these countries offer an adequate level of data protection, as established by specific decisions of the European Commission.

The transfer of personal data to third parties resident or located in countries that do not belong to the European Union and that do not ensure adequate levels of protection will be performed only with the consent of the interested party or following the conclusion between the Company and said parties of specific agreements, containing safeguard clauses and appropriate guarantees for the protection of personal data, so-called "standard contractual clauses", also approved by the European Commission, or if the transfer is necessary for the conclusion and execution of the contract between the Company and the interested party or for the management of his requests.

9. Data Retention

The images will be stored for a period of twelve months starting from the conclusion of the works and the production of the video in "Time- Lapse " format.

At the end of this period, the Supplier will process, after having anonymized the personal data, a video in "Time- Lapse " format and will deliver it to Kedrion.

Once the video has been delivered, the Supplier will delete the recorded images and the video will be used by Kedrion, in an anonymous form, for promotional purposes as indicated above.

10. Rights of the interested party

In accordance with the Regulation, you can exercise the following rights at any time and free of charge and without any particular charges or formalities for your request:

Right of access : Article 15 of the Regulation allows you to obtain from the data controller confirmation as to whether or not data concerning you is being processed and, where that is the case, to obtain access to such data.

Right to rectification : Article 16 of the Regulation allows you to obtain from the data controller the rectification of inaccurate personal data concerning you without undue delay. Taking into account the purposes of the processing, the data subject has the right to obtain the integration of incomplete personal data, including by providing a supplementary statement.

Right to erasure : Article 17 of the Regulation allows you to obtain from the data controller the erasure of personal data concerning you without undue delay if one of the reasons provided for by the law exists.

Right to restriction : Article 18 of the Regulation allows you to obtain from the data controller the restriction of processing when one of the hypotheses provided for by the law occurs.



Right to object : Article 21 of the Regulation allows you to object at any time, for reasons relating to your particular situation, to the processing of personal data concerning you pursuant to Article 6 of the Regulation, paragraph 1, letters e) or f).

Right to portability : Article 20 of the Regulation allows you to receive the personal data concerning you provided to a data controller in a structured, commonly used and machine-readable format and you have the right to transmit those data to another data controller without hindrance from the data controller to whom you have provided them according to the conditions set out in the law.

Right to complain : Article 77 of the Regulation, if you consider that the processing of your personal data violates the Regulation, grants you the right to lodge a complaint with a supervisory authority, in particular in the Member State where you habitually reside, work or where the alleged violation occurred.

The Data Controller shall proceed in this direction without delay and, in any case, no later than one month after receiving your request.

The deadline may be extended by two months, if necessary, taking into account the complexity and number of requests received by the Data Controller. In such cases, the Data Controller, within one month of receiving your request, will inform you and make you aware of the reasons for the extension.
