

INFORMATION NOTICE FOR VISITORS PURSUANT TO ARTICLE 13 OF THE EU REGULATION AND THE PRIVACY CODE AS AMENDED BY LEGISLATIVE DECREE 101/2018

Kedrion S.p.a., in its capacity as Data Controller (hereinafter "Controller"), protects the confidentiality of your personal data and ensures the necessary protection against any event that may put them at risk of violation. The Controller implements policies and practices regarding the collection and use of personal data and the exercise of the rights recognized by the applicable regulations. The Controller ensures to update the policies and practices adopted for the protection of personal data whenever necessary and, in any case, in the event of regulatory and organizational changes that may affect the processing of your personal data. The Controller has appointed a Data Protection Officer (DPO) whom you can contact if you have questions about the policies and practices adopted. PERSONAL DATA AND PURPOSES

The personal data collected are identification data and include:

- name, surname;
- place and date of birth;
- physical address;

These data are obtained through the presentation of your identity document. These personal data are collected by the Controller to ensure compliance with the obligations it is required to guarantee for safety and risk management arising from emergency situations within the buildings and facilities where it operates.

LEGAL BASIS FOR PROCESSING

The legal basis for the processing of data is represented by specific legal obligations and the legitimate interest of the Controller to safeguard the assets belonging to the company's property and to ensure the protection and safety of your person as well as third parties.

COMMUNICATION AND DISCLOSURE OF PERSONAL DATA

The communication of your personal data mainly occurs to the authorities responsible for public safety control and supervision, to those who, on behalf of the Controller, oversee health and safety in the workplace, and to third parties appointed by the Controller to carry out surveillance and concierge activities. The Controller does not transfer your personal data abroad, neither within nor outside the EU. Your personal data will not be disseminated or disclosed to unidentified and unidentifiable subjects, not even as third parties.

MANDATORY DATA PROVISION

The personal data concerning you and identifying you are necessary to fulfill specific legal obligations to which the Controller is bound, which cannot be derogated or disregarded.

DATA RETENTION

The processing of data concerning you is carried out through electronic and manual means and tools made available to subjects acting under the authority of the Controller and duly appointed as authorized persons who have received specific training. Personal data are stored, in case, in protected electronic archives using effective and adequate security measures to counter the risks of violation considered by the Controller. Personal data are retained for the time necessary to fulfill the obligations to which the Controller is bound and, in any case, for the period ranging from a minimum of one day (the day of the visit) to the maximum period provided by the Data Retention plan and the company's policies held by the

Controller. Exceptions are made for cases where, during your visit, events occur that jeopardize the safety of the buildings where the Controller operates, requiring the intervention of the competent authorities, also in collaboration with third parties/recipients responsible for security and prevention activities within the Controller's structure, to conduct any investigations into the causes that led to the event.

RIGHTS OF THE DATA SUBJECT

At any time, you can exercise your rights towards the Data Controller, pursuant to Articles 15 and following of EU Regulation 2016/679 and the Privacy Code as amended by Legislative Decree 101/2018, i.e., you can, for example, obtain confirmation of the existence of your personal data and request their communication in an intelligible form. You will also have the right to obtain the updating, rectification, integration, and deletion of data or the limitation of processing, as well as the right to object, in whole or in part, for legitimate reasons, to the processing of your personal data, even if pertinent to the purpose of collection.

COMPLAINT

Pursuant to Article 77 of EU Regulation 2016/679, you also have the right to lodge a complaint with the Data Protection Authority if you believe that the processing violates the aforementioned Regulation and the Privacy Code as amended by Legislative Decree 101/2018.
