

SUPPLIER INFORMATION NOTICE PURSUANT TO ART. 13 OF EU REGULATION 679/2016 AND THE PRIVACY CODE

(as amended by Legislative Decree 101/2018)

I. Introduction

For Kedrion S.p.A., your privacy and the security of your personal data are particularly important. Therefore, we collect and process such data with the utmost care and attention, adopting specific technical and structural measures to ensure full security of the processing. We inform you, pursuant to Art. 13 of the European Regulation 2016/679 (hereinafter "Regulation") and the Privacy Code as amended by Legislative Decree 101/2018, that the processing of your personal data is carried out in a manner appropriate to ensure the security and confidentiality of your data; the processing is carried out using IT and/or telematic means, as detailed in this information notice. This information notice concerns the processing of personal data of suppliers with whom Kedrion S.p.A. establishes or intends to establish a contractual relationship aimed at the supply of goods or services (hereinafter simply "Suppliers").

II. Data Controller

The processing of your personal data is carried out by Kedrion S.p.A., as the Data Controller, pursuant to and for the purposes of EU Regulation 2016/679 and the Privacy Code as amended by Legislative Decree 101/2018. - Data derived from the third-party qualification platform used by the company, including public reputation information;
- Data derived from the qualification information questionnaire completed by the supplier;
- Data necessary to implement the payment process.

- Data communicated by the Supplier based on the procedures in force at Kedrion for the protection of health, safety, and the environment in the contracting of works and services, including: declaration on the personnel of the Supplier employed in the contract, nominally identified and related declaration of regular employment and regularity of remuneration/contributions/insurance; certificate of health suitability for the job for each worker employed in the contract; safety training certificates and for the use of machines and equipment/working at height/access to confined spaces and anything else necessary to verify considering the object of the contract for each worker employed in the contract; data to demonstrate the regularity of remuneration, contributions, and insurance of the personnel employed in the contract; including: copy of the LUL with reference to each worker employed in the contract (copy of the Unilav in case of new hires).

PERSONAL DATA PROCESSED BY KEDRION IN RELATIONSHIPS WITH CONSULTANT/PROFESSIONAL SUPPLIERS TO WHOM IT CONTRACTS CONSULTANCY OR REQUESTS PROFESSIONAL SERVICES In addition to the processing of data mentioned in point 1 above, for the purposes indicated therein, in relationships with Consultant/Professional Suppliers to whom it contracts consultancy or requests professional services, Kedrion processes the following personal data:
- Data regarding the existence of relationships with public administration, including employment relationships;
- Data regarding the existence of assignments in the Public Administration;
- Absence of causes of incompatibility and/or conflict of interest concerning the contractual relationship with Kedrion;
- Amounts received by the healthcare professional in the context of relationships with Kedrion, for the publication of the same in compliance with the "transparency" regulations.

IV. Communication and Dissemination of Personal Data The collected data may be communicated to recipients, appointed pursuant to Art. 28 of EU Regulation 2016/679, who will process the data as Data Processors of Kedrion S.p.A. and/or to third parties acting as independent Controllers for the fulfillment of contractual and/or regulatory obligations. Specifically, your data may be communicated to:

- Financial administrations and public entities in compliance with regulatory obligations also deriving from membership;
- Companies involved in administrative, accounting, and business process management (e.g., auditing firms, tax consultants, management consultants, legal consultants);
- Banking institutions for the management of collections and payments;
- Data processing and IT service companies;
- Any and all authorities and/or public entities involved, in any capacity and by law, in the processes related to the treatments described above.

It is specified that the updated list of external Data Processors is available at the company's offices.

V. Transfer of Data to a Third Country and/or International Organization

Personal data may be transferred abroad (in EU and non-EU countries) to companies belonging to the Kedrion group, in compliance with the guarantees provided by the applicable legislation (existence of an adequacy decision or standard contractual clauses). It is specified that the use of IT storage systems may also involve the transfer of data abroad (both EU and non-EU), always in compliance with the applicable legal provisions and, in any case, ensuring maximum security.

VI. Mandatory or Optional Nature of Providing Personal Data

The provision of data is considered necessary, and failure to provide it will make it impossible for the Data Controller to proceed with the activities related to the main processing, i.e., the impossibility of managing the supply contract and the obligations, including legal ones, arising from the established relationship.

VII. Methods of Processing and Storage of Personal Data

The processing of data is carried out through paper supports or IT applications by internal subjects specifically authorized and trained. These subjects are allowed access to your personal data to the extent and within the limits necessary for the performance of the processing activities concerning you. The data are stored in paper, IT, and telematic archives located within the European Economic Area and may be transferred to non-EU countries, with full assurance of the guarantees provided by European legislation.
