

VIDEO SURVEILLANCE INFORMATION NOTICE PURSUANT TO ARTICLE 13 OF EU REGULATION 679/2016 AND THE PRIVACY CODE

(as amended by Legislative Decree 101/2018)

Introduction

For Kedrion S.p.A., your privacy and the security of your personal data are particularly important. Therefore, we collect and process such data with the utmost care and attention, while adopting specific technical and structural measures to ensure the full security of the processing. We inform you, pursuant to Article 13 of the European Regulation 2016/679 (hereinafter "Regulation") and the Privacy Code as amended by Legislative Decree 101/2018, that the processing of your personal data is carried out in ways that ensure the security and confidentiality of your data; the processing is carried out using IT and/or telematic supports, as detailed in this information notice. This information notice concerns the processing of personal data (images/video recordings) collected through the video surveillance system - which meets internal security needs and monitors access to the facilities where the Controller operates - installed at the following locations:

- Production plant in Bolognana (LU);
- Logistics hub Frascone (LU);
- Warehouse Castelvecchio Pascoli (LU);

- Offices Piazza Missori Milan (MI);
- Plant Sant'Antimo (NA);

Data Controller

The processing of your personal data is carried out by Kedrion S.p.A., as the Data Controller, pursuant to and for the purposes of EU Regulation 2016/679 and the Privacy Code as amended by Legislative Decree 101/2018. Types of Data and Purposes of Processing

The data processed by Kedrion S.p.A. are specifically the images and video recordings collected through the video surveillance system installed at the aforementioned locations. Kedrion S.p.A. will process the collected images in compliance with the conditions of lawfulness provided by Article 6 of EU Regulation 2016/679 and to the extent strictly necessary to fulfill the following purposes: a) facilitate the right of defense of the Controller or third parties in case of any unlawful acts; b) protect the safety of employees, assets, property, and individuals; The purposes comply with the principles of fairness and lawfulness and the observance of legal provisions regarding the protection of your data privacy, including those of the general provision of the Data Protection Authority regarding video surveillance dated

April 8, 2010, currently in force, and Article 4, paragraph 1, of Law No. 300/1970. The collected images will not be used for controls, even indirect, of employees possibly filmed during their work performance.

Communication and Disclosure of Personal Data

The collected data may be communicated to recipients, appointed pursuant to Article 28 of EU Regulation 2016/679, who will process the data as external Data Processors of Kedrion S.p.A. and/or to third parties acting as independent Controllers for the fulfillment of contractual and/or legal obligations. Specifically, your data may be communicated to:

- Authorities responsible for safety control and supervision;
- Companies for the management and maintenance of the video surveillance system;
- Concierge and surveillance companies;
- Judicial or police authorities to fulfill legal obligations. It is specified that the updated list of external Data Processors is available at the company's offices.

Transfer of Data to a Third Country and/or an International Organization

The Controller does not transfer your personal data abroad. Your personal data will not be disseminated or disclosed to unidentified and unidentifiable subjects, not even as third parties.

Legal Basis for Processing

The processing of data is necessary for the pursuit of the legitimate interest of the company, namely for security needs and protection of company assets. For these purposes, the processing is considered indispensable and necessary.

Methods of Processing and Storage of Personal Data

Each site is equipped with a video surveillance system. The processing of images is carried out through IT procedures, and the viewing and recording of images acquired by the video surveillance system are done only by the Controller, appointed external Data Processors, and subjects specifically authorized/designated for processing. The video surveillance system exclusively involves the processing of images captured by the recordings, which, in relation to the locations of the cameras, concern areas owned by the Controller. The system is designed to both view and record the filmed images.

Retention Period or Criteria Used to Determine Such Period

The images are stored for no longer than 24 hours, except for additional retention needs related to holidays, weekends, or office closures, and in case of a specific investigative request from the judicial or police authorities or the possible exercise of the right of access recognized to the data subject pursuant to Articles 15 and following of EU Regulation No. 679/2016 (in any case up to a maximum period of 7 days).

Rights of Data Subjects and Methods of Exercising Them

Your rights are those provided by EU Regulation in Articles 15-22 and those provided by the Privacy Code as amended by Legislative Decree 101/2018, including but not limited to:

- access;
- rectification;
- deletion;
- limitation of processing;
